1. The Naukunda Rural Municipality invites sealed bids or electronic bids from Nepalese eligible bidders for the Construction of Aapchaur, LhoGaun, RanaTole Water Supply Project under National Competitive Bidding procedures.

4. Pre-bid meeting shall be held at Naukunda Rural Municipality, Saramthali, Rasuwa at 12:00 pm on 2078/01/13.
5. Sealed or electronic bids must be submitted to the office Naukunda Rural Municipality, Saramthali, Rasuwa through PPMO website www.bolpatra.gov.np/egp on or before 12:00 pm on 2078/02/09. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2078/02/09 at the office of Naukunda Rural Municipality, Saramthali, Rasuwa. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs. 1,00,000, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2078/06/09)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
